John H. Armstrong

Allis, Oswald T. *Prophecy and the Church*. Phillipsburg, New Jersey: Presbyterian & Reformed, 1945. This standard work is built on the covenantal system of interpretation.

Bahnsen, Greg L. *Theonomy in Christian Ethics*. Phillipsburg, New Jersey: Presbyterian & Reformed, 1977. The definitive presentation of the system known as "theonomy." It seeks to do serious exegetical work with important texts.

Bahnsen, Greg L. and Kenneth L. Gentry, Jr. *House Divided: The Breakup of Dispensational Theology.* Tyler, Texas: Institute for Christian Economics. 1989. A significant case for the claim regarding the "breakup" of dispensational theological foundations within the evangelical movement.

*Bahnsen, Greg L. and Walter C. Kaiser, Jr., Douglas J. Moo, Wayne G. Strickland and Willem A. Van Gemeren. *The Law, the Gospel and the Modern Christian: Five Views*. Grand Rapids: Zondervan, 1993. This is the absolute best overview of the various views of the new covenant and the law in print. If you want to read for yourself the basic approaches, wrestle with their implications and nuances carefully, and draw deductions yourself, study this important volume.

Baker, D. L. *Two Testaments: One Bible*. Rev. ed. Downers Grove, Illinois: InterVarsity, 1991. An important scholarly work which addresses issues related to the hermeneutical concerns regarding the testaments.

Barker, William S. and W. Robert Godfrey, eds. *Theonomy: A Reformed Critique*. Grand Rapids: Zondervan, 1990. This important book has several valuable essays. It also demonstrates that a consistently Reformed hermeneutical position has a hard time answering the questions raised by theonomy.

Barth, Markus. *Israel and the Church*. Richmond: John Knox Press, 1969. The son of the famous Karl Barth was himself a noteworthy exegete with more liberal presuppositions regarding the authority of the Holy Scripture.

Bass, Clarence. *Backgrounds to Dispensationalism*. Grand Rapids: Eerdmans, 1977. This "older" work is valuable, though the tone is anything but irenic at times.

Belcher, Richard P. *Dispensationalism and Covenant Theology*. Southbridge, Massachusetts: Crowne Publishing Company (P.O. Box 688, Southbridge, Massachusetts 01550), 1986. A simple introduction that surveys the positions fairly.

Belcher, Richard P. and Richard P. Belcher, Jr. *A Layman's Guide to the Sabbath Question*. Southbridge, Massachusetts: Crowne Publishing Company, 1991. A good and well-organized overview.

Bell, William Everett. "The New Covenant." Th.M. thesis, Dallas Theological Seminary, 1963. This work can be found in seminary libraries on microfilm and is useful for researchers.

Berkhof, Louis. *Systematic Theology*. New Combined Edition. Grand Rapids: Eerdmans, 1996. Berkhof, a clear, systematic Reformed writer, presents the classic thought of the Reformed Confessions regarding the covenant of grace, the two testaments, and the law.

Betz, Hans Dieter. *Galatians*. Hermeneia. Philadelphia: Fortress, 1979. One of the most important contemporary commentators who deals carefully with the questions related to the two covenants in Paul's important epistle.

Blaising, Craig A. and Darrell L. Bock, eds. *Dispensationalism, Israel and the Church*. Grand Rapids: Zondervan, 1992. This collection of essays includes some of the very best, modern dispensational argumentation related to the new covenant.

Blomberg, Craig L. *Mark. The New American Commentary.*Nashville: Broadman & Holman, 1992. An important new commentary which deals well with law-grace issues.

Blomberg, Craig L. *Interpreting the Parables*. Downers Grove, Illinois: InterVarsity, 1990. Blomberg here, as in his commentary on Mark, offers some solid work in terms of the hermeneutic of new covenant theology.

Bornkamm, Gunther, and Gerhard Barth, and Heinz Joachim Held, eds. *Tradition and Interpretation in Matthew*. Philadelphia: Westminster, 1963. See Gerhard Barth's article on "Matthew's Understanding of the Law."

Bruce, F. F. *Paul: Apostle of the Heart Set Free*. Grand Rapids: Eerdmans, 1977. This is a wonderful book; chapter 18, "What the Law Could Not Do," is extremely important to the theme of the new covenant.

Bright, John. *The Kingdom of God*. Nashville: Abingdon-Cokesbury, 1953. A good study that has served the past generation well.

*Bromiley, Geoffrey, ed. *The International Standard Bible Encyclopedia*. Third edition, Volume 3. Grand Rapids: Eerdmans, 1986. See article by Robert H. Mounce and Carl B. Hoch, Jr., on "New; Newness."

Burgess, Edward Earl. *Christ, the Crown of the Torah*. Grand Rapids: Zondervan, 1986. An out-of-print book of some value.

Campbell, Roderick. *Israel and the New Covenant*. Phillipsburg, New Jersey: Presbyterian & Reformed, 1954. A solid Reformed approach that presents the older hermeneutical position well.

*Carson, D. A., ed. *From Sabbath to Lord's Day*. Grand Rapids: Zondervan, 1982. A collection of essays well worth reading on this issue. A useful introduction to some of the issues related to new covenant theological concerns.

*Carson, D. A. *Matthew. The Expositor's Bible Commentary: Matthew-Luke*, Vol. 8. Edited by Frank E. Gaebelein. Grand Rapids: Zondervan, 1984. Carson's exegesis, especially on Matthew 5-7, is essential for the new covenant. His approach to the theology of Christ as the giver of law is vital.

Cassirer, Heinz W. *Grace & Law*. Grand Rapids: Eerdmans, 1988. A contrast between Kant's understanding of freedom and law with the apostle Paul's.

Chafer, Lewis Sperry. *Grace*. Grand Rapids: Zondervan, 1922. A historic defense of dispensationalism with regard to the subject.

Chantry, Walter J. God's Righteous Kingdom. Edinburgh: Banner of Truth, 1980. Seeks to show how both new covenant views and theonomy fall short of biblical teaching. I fear neither side will feel its view has been presented fairly and accurately, which limits the usefulness of the book in many ways.

Clowney, Edmund P. *The Unfolding Mystery: Discovering Christ in the Old Testament*. Colorado Springs: NavPress, 1988. One of the most important and valued little books in

my library. Every minister should read it!

Drane, John W. *Paul: Libertine or Legalist?* London: SPCK, 1975. A scholarly survey of the question.

Dumbrell, William J. Covenant and Creation: A Theology of Old Testament Covenants. Nashville: Nelson, 1984. A good study.

Dumbrell, William J. *The End of the Beginning*. Grand Rapids: Lancer (Baker), 1985. A valuable look at important issues which parallel the theme of the new covenant. Recommended.

Dunn, James D. G. *Jesus, Paul and the Law.* Louisville: Westminster, 1990. Dunn's work on the law is very important for scholars.

Fairbairn, Patrick. *The Revelation of Law in Scripture*. Grand Rapids: Zondervan, 1957. A very important Reformed presentation that serious readers should consult.

Fairbairn, Patrick. *The Typology of Scripture*. Two vols. reprint. Grand Rapids: Baker, 1975. An extremely useful older work.

*Feinberg, John S., ed. *Continuity and Discontinuity*. Wheaton, Illinois: Crossway, 1988. This out-of-print series of essays given in honor of Dr. S. Lewis Johnson is extremely valuable. See Douglas J. Moo, "The Law of Moses or the Law of Christ," for a masterful and very important essay in this volume.

Fuller, Daniel P. Gospel and Law: Contrast or Continuum? Grand Rapids: Eerdmans, 1980. This book will unsettle both covenant and dispensational views, but what it puts in their

place is not always satisfying either.

Fuller, Daniel P. *The Unity of the Bible: Unfolding God's Plan for Humanity*. Grand Rapids: Zondervan, 1992. Based upon Fuller's class material and useful for the serious student. Seeks, with attention to the text, to show the unity of the two testaments within the one Bible.

Gentry, Kenneth L., Jr. *God's Law in the Modern World: The Continuing Relevance of Old Testament Law.* Phillipsburg, New Jersey: Presbyterian & Reformed, 1993. The subtitle tells you the author's view. Not convincing to my mind.

Goppelt, Leonard. *Typos*. Grand Rapids: Eerdmans, 1982. An important scholarly work which works at understanding the role of types exegetically and covenantly.

Guelich, Robert A. *The Sermon on the Mount*. Waco, Texas: Word, 1982. The late Robert Guelich gave the church a valuable exegetical work.

Gundry, Robert. *Matthew: A Commentary on His Literary and Theological Art.* Grand Rapids: Eerdmans, 1982. Another extremely useful technical commentary for the scholar and serious reader.

Harris, Murray J. 2 Corinthians. The Expositor's Bible Commentary: Romans-Galatians. Vol. 10. Edited by Frank E. Gaebelein. Grand Rapids: Zondervan, 1978. A good and eminently useful work for the study of the new covenant in this important epistle.

Harrisville, R. A. *The Concept of Newness in the New Testament*. Minneapolis: Augsburg, 1960. An earlier work of considerable use.

Hendriksen, William. *Exposition of the Gospel According to Matthew*. Grand Rapids: Baker, 1973. Hendriksen is always a fair and readable representative of the Reformed position, which he consistently represents well.

Hendriksen, William. *Israel and the Bible.* Grand Rapids: Baker, 1968. This little book is good for the hermeneutical developments he offers in clear language.

*Hoch, Carl B., Jr. All Things New: The Significance of Newness for Biblical Theology. Grand Rapids: Baker, 1995. By far and away this fair, even-handed and important work is at the top of the list for resources on the new covenant.

Howell, R. B. C. *The Covenants*. Wilmington, Ohio: Hampton House (P. O. Box 112, Wilmington, Ohio 45177), (1855), reprint 1991. Howell was a major figure among the Baptists of the old South and should be read again.

Howell, R. B. C. *The Cross and the Covenants*. Harrisonburg, Virginia: Sprinkle Publications (1854 ed.), 1994 reprint. Valuable reprint volume.

Hughes, Philip Edgcumbe. *Paul's Second Epistle to the Corinthians*. NICNT. Edited by F. F. Bruce. Grand Rapids: Eerdmans, 1962. One of the truly fine works on this important letter.

*Jewett, Paul K. *The Lord's Day: A Theological Guide to the Christian Day of Worship.* Grand Rapids: Eerdmans, 1971. A very important study which is very convincing to my mind.

Kaiser, Walter C., Jr. Toward an Old Testament Theology. Grand Rapids: Zondervan, 1978. Kaiser is always provoca-

tive, if nothing else, but does not account for important concerns which do not fit his thesis easily.

Kaiser, Walter C., Jr. *Toward Old Testament Ethics*. Grand Rapids: Zondervan, 1983. Another useful Kaiser volume, though at times eccentric in its own way.

Kaseman, Ernst. *Perspectives on Paul*. Philadelphia: Fortress, 1971. A scholarly work of some note.

*Kevan, Ernest. *The Grace of Law*. Pittsburgh: Soli Deo Gloria, 1976. An extremely important explanation and defense of the Puritan approach to law and covenant. Serious readers must grapple with his arguments.

*Ladd, George E. A Theology of the New Testament. Grand Rapids: Eerdmans, 1974. This important work, by the late New Testament scholar, is highly detailed, at times brilliant, and very important for the serious student.

MacGregor, Geddes. Corpus Christi: The Nature of the Church According to the Reformed Tradition. Philadelphia: Westminster, 1958. An older work of some value for understanding the historical perspectives.

Martin, Ralph P. 2 Corinthians. Word Biblical Commentary. Edited by David A. Hubbard and Glenn W. Barker. Waco, Texas: Word, 1986. Martin's exegetical work is always of some value for the Greek student.

Mauro, Philip. *The Hope of Israel: What Is It?* Swengel, Pennsylvania: Reiner, 1970. This seemingly out-of-print volume is worth finding. Mauro is an interesting read considering he left dispensationalism and explained clearly why he did so. *McComiskey, Thomas E. *The Covenants of Promise*. Grand

Rapids: Baker, 1985. A seminal book of great importance on the matter of covenants. Even if you disagree, McComiskey is always a prudent guide who seeks to remain a careful student of the text of Scripture. Read it!

Mendenhall, George E. Law and Covenant in Israel and the Ancient Near East. Pittsburgh: Biblical Colloquium, 1955. A significant earlier work for scholars.

Mounce, Robert H. *Matthew. Good News Commentaries*. Ed. W. Ward Gasque. Peabody, Massachusetts: Hendrickson, 1985. A valuable survey of the relevant texts on the law and the covenants in Matthew.

Munck, Johannes. *Christ and Israel: An Interpretation of Romans 9-11.* Philadelphia: Fortress, 1967. A scholarly overview of a relevant text for new covenant study.

*Murray, John. *Principles of Conduct*. Grand Rapids: Eerdmans, 1957. A profoundly important study of ethical concerns which flow from Reformed exegesis of the covenants.

North, Gary. *The Dominion Covenant: Genesis*. Second ed. Tyler, Texas: Institute for Christian Economics, 1987. Strong reconstruction, or theonomy, position.

Pieters, Albertus. *The Seed of Abraham*. Grand Rapids: Eerdmans, 1950. This immensely valuable little book is sadly out-of-print. I have read it several times and find it quite useful personally.

*Poythress, Vern. *The Shadow of Christ in the Law of Moses*. Brentwood, Tennessee: Wolgemuth & Hyatt, 1991. A serious Reformed exegete who would not agree with some direc-

tions of so-called new covenant theology but seeks to anchor traditional Reformed concerns in Christ in a most helpful and edifying manner. Shows how the punishments and penalties of the law prefigure the destruction of sin and guilt through Christ.

*Povthress, Vern. Symphonic Theology: The Validity of Multiple Perspectives in Theology. Grand Rapids: Zondervan, 1987. Poythress is one of the brightest thinkers we have from the Reformed community. Very valuable study, even and most fair.

Reisinger, John G. But I Say Unto You ... Southbridge, Massachusetts: Crowne Publications (P. O. Box 688, Southbridge, Massachusetts 01550), 1989. Useful but not always careful. The polemical style will put off many who might otherwise profit.

Reisinger, John G. Tablets of Stone. Southbridge, Massachusetts: Crowne Publications, 1989. Useful, but at times not aware enough of inherent difficulties in the field.

Ridderbos, Herman N. Paul: An Outline of His Theology. Grand Rapids: Eerdmans, 1975. I rank this as one of the two or three most important theological studies touching upon the new covenant.

*Robertson, O. Palmer. The Christ of Covenants. Grand Rapids: Baker, 1980. An important Reformed critique and overview. Should be read by all interested students.

Rushdoony, Rousas John. The Institutes of Biblical Law. Phillipsburg, New Jersey: Presbyterian & Reformed, 1973. A massive study presenting the position of theonomy, which builds an entire theology on presupposition that the law of Moses is essentially the same as the law of Christ.

Ryrie, Charles C. Biblical Theology of the New Testament. Chicago: Moody, 1959. A useful book but flawed, at several critical points, by the system it embraces.

Ryrie, Charles C. Dispensationalism Today, Chicago: Moody, 1965. An important defense of older, more traditional, dispensationalism.

Sanders, E. P. Jewish Law from Jesus to the Mishnah. Philadelphia: Trinity International, 1990. Sanders is an important work for well-trained scholars. He is not always a safe guide but an important one for those who are discerning scholars.

Sanders, E. P. Paul and Palestinian Judaism. Philadelphia:

Fortress, 1977. One of his earlier works on the subject.

Sanders, E. P. Paul, the Law and the Jewish People. Philadelphia: Fortress, 1983. A follow-up study.

Saucy, Robert. The Case for Progressive Dispensationalism. Grand Rapids: Zondervan, 1993. Saucy is a stimulating writer from the dispensational side and always worth reading carefully.

*Schreiner, Thomas R. The Law and Its Fulfillment, Grand Rapids: Baker, 1993. At times Schreiner is not as clear as I prefer, but this is a useful and important work of contemporary importance.

Smith, Ralph L. Old Testament Theology. Nashville: Broadman & Holman, 1993. A newer work of value.

Stevens, George. *The Theology of the New Testament*. Second rev. ed. Edinburgh: T. & T. Clark, 1918. This older standard work was used in graduate class study in the early 1970s by my professors. Still worth consulting, though Ladd has surpassed it in value.

Stockhausen, Carol Kern. *Moses' Veil and the Glory of the New Covenant*. Analecta Biblica, vol. 116. Rome: Biblical Institute, 1989. A highly technical, important work. See Carl Hoch's comments in this issue.

Stott, John R. W. *Christian Counter-Culture: The Message of the Sermon on the Mount*, Downers Grove, Illinois: InterVarsity, 1976. Stott is useful because he remains in the text always.

Van Gemeren, Willem A. *The Progress of Redemption*. Grand Rapids: Zondervan, 1988. Another Reformed scholar who is willing to break new ground in his study of the text.

*Vos, Geerhardus. *Biblical Theology: Old and New Testaments*. Grand Rapids: Eerdmans, 1948. Perhaps the most important defense we have of the case for the Reformed approach to the two testaments. A text in many classes, and rightly so. A must read.

Vos, Geerhardus. *The Teaching of Jesus Concerning the Kingdom of God and the Church*. Reprint. Phillipsburg, New Jersey: Presbyterian & Reformed, 1972. Once again, very useful.

Westerholm, Stephen. *Israel's Law and the Church's Faith*. Grand Rapids: Eerdmans, 1988. An extremely important corrective to the work of E.P. Sanders and James D.G. Dunn.

Willis, Wesley R. and John R. Wesley. *Issues in Dispensationalism*. Chicago: Moody, 1994. The article by John R. Master on "The New Covenant" is important and useful.

Wright, Christopher J. H. An Eye for an Eye: The Place of Old Testament Ethics Today. Downers Grove, Illinois: InterVarsity, 1983. This is a readable and profitable volume.
